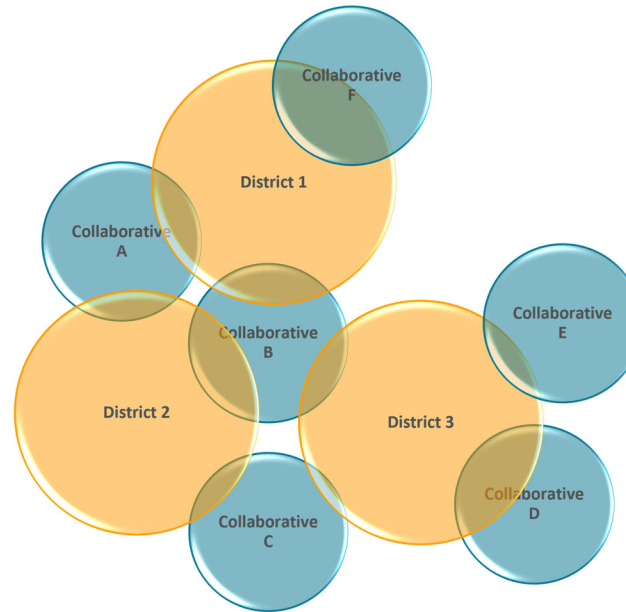

Efficiency

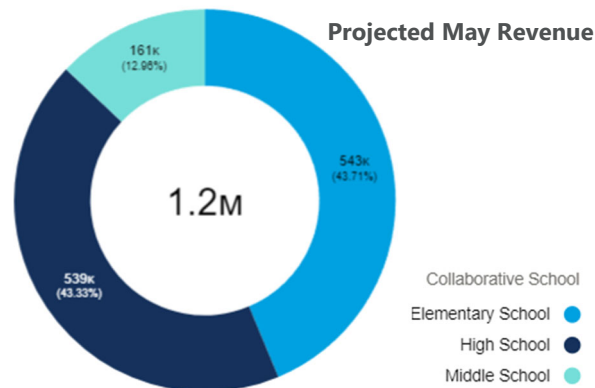

Transparency

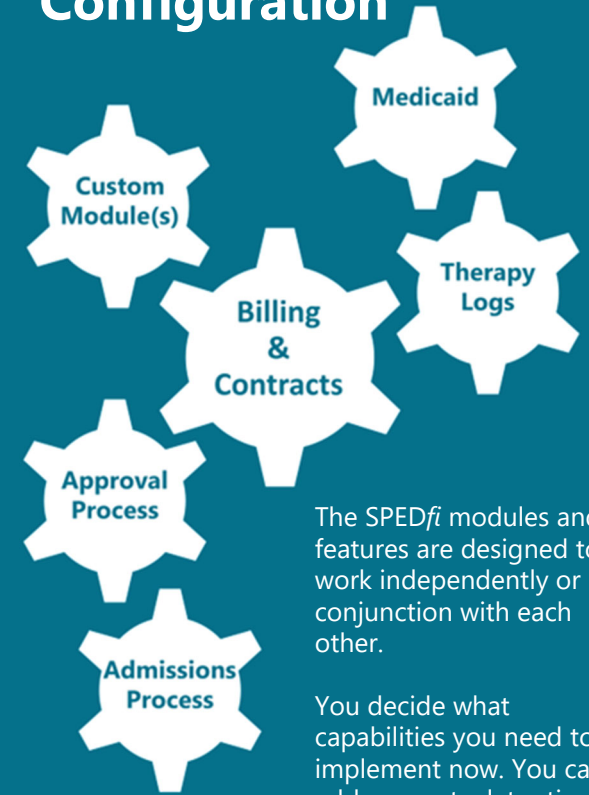
Interactions with the system, such as changes to student information, costs, and payments are timestamped. The system provides a fully transparent audit trail.
